- (iii) Separate technical bids and EMD deposit are required for the works.
- (iv) The tender bids will be opened on 04th October 2010 at 11.00 am.
 - a. In the tenderer should give details of technical qualification with sufficient proof.
 - b. The experience of the firm in the manufacturing of the said items.
 - c. Name of the organizations where the work is being done by the firm.
 - d. Rs. 20,000/- for EMD along with the cost of tender form should be enclosed in the form of DD drawn in favour of “Finance Officer, MGAHV, Wardha” payable at Wardha along with the technical bids.
- (v) The technical and financial bid should indicate the item-price of the item (works) and should be sealed by the bidder in a cover and superscribed as “Tender for Computer Lab Furnishing” on the top of the cover.

1. Only reputed and established firms who are capable in the above said field should apply.
2. The prices quoted should be inclusive of all taxes. TDS will be deducted as per government rules, if applicable.
3. Earnest money shall ordinarily be 20,000/-. The Earnest money will be liable to be forfeited, if the tenderers withdraws, impairs or derogates from the tender in any respect within the period of validity of his tender.
4. No tender will be accepted unless accompanied by a crossed Account Payee Bank Demand Draft as mentioned above towards Tender Form & Earnest Money Deposit (separately) drawn in favour of The Finance Officer, MGAHV, Wardha.
5. The tender documents are not transferable.
6. No person making a tender shall be allowed at any time on any account whatsoever, to claim for revision or modification of the rates quoted by them. No clerical error, typographical error will be considered after the opening of the tender. Conditions such as subject to the availability of stocks, supplies will be made as and when supplies received from the principals etc., will not be considered under any circumstances.
7. The quotation should be typewritten and every correction in the tender if any should invariably be initialed by the tenderer failing which the tender will be rejected.
8. The tenderers should specify the minimum period required for providing and fixing tables (as per the design obtained from the University) from the date of receipt of firm order/work order. Further extension of time will not be provided for completion than the minimum time indicated in the tender by the supplier after firm orders are placed by MGAHV, Gandhi Hills, Post Box-16, Umri, Wardha.
9. Payment will be made only after completing the work satisfactorily and certificate to that effect from user department.
10. The loss to Mahatma Gandhi Antarrashtriya Hindi Vishwavidyalaya, Wardha if any, incurred on account of purchase made elsewhere or by failure, neglect or refusal on the part of the tenderers to supply according to the terms of agreement, will be recovered from them.
11. The tenderer will not be entitled for any payment whatsoever, for such articles for infringements of the stipulation of the conditions or for justifiable reasons, the contract may be terminated by the Registrar and the tenderer shall be liable for losses sustained by the MGAHV on the consequences of the termination which may be

- recovered from the EMD/FDR of their invoices become due to them. In the event of such amount being insufficient, the balance will be recovered personally from the tenderer.
12. All tenderers should furnish a declaration in the enclosed format, which should form a part of tender enclosed documents. Tenders received without the declaration will not be considered.
 13. A person/firm having once given a tender shall not withdraw it after its opening/acceptance and if he does so, the Earnest Money paid by him will be forfeited and the tenderer is liable to make good the loss sustained.
 14. The tender without technical specifications will be rejected.
 15. Any dispute arising out of this contract is subject to jurisdiction of the courts of Wardha only.
